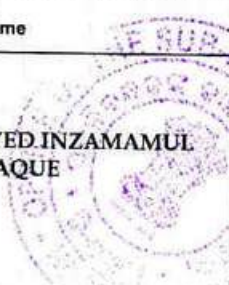

Appointment of the Trustees:

In the event of death, resignation or continued absence of a trustee, the vacancy so created shall be filled as hereinafter provided by the remaining trustees through a resolution passed and recorded in the book of the proceedings of the trust board. - c) The TRUSTEES will be at liberty to invest and invested the money, income and accretions of the income thereof in such investments as the TRUSTEES in their absolute discretion shall think ,fit and proper.
- d) To acquire by purchase, gifts, lease, exchange, hire or otherwise with or without consideration ,properties ,movable or immovable for any or more of the objects of the TRUST.
- e) To manage,lease,mortgage,sell,dispose off theTRUST,provided always that the mortgage,lease or sale of any such assets or property of the TRUST shall be in accordance with the rules and regulations and shall be for achieving the objects of the TRUST.
- f) To purchase and otherwise acquire land by way of gift or otherwise and to build and maintain houses, shelter homes, short stay homes, etc and improve the same.
- g) To borrow with or without security or raise money in such manner and on such terms as may be necessary for achieving the objects of the trust, subject to previous approval of the TRUSTEES.
- h) The TRUSTEES shall cause trust and accurate accounts be kept of all monies received and all matters and things in respect thereof, in course of management of TRUST property or relating to the carrying out of the objects and purposes of the TRUST as well as of the assets credit and effects of the TRUST properties.
- i) To open account in the name of the TRUST, TRUSTEES and or institutions run/conducted by the TRUST with a bank(s) to operate such accounts and to give instructions/documents to the bank and to provide for opening, operation and closing of such account by one more of the TRUSTEES or by an authorized agent/representative appointed by the **MANAGING TRUSTEE**.
- j) To adjust, settle, compromise, compound, and refer to arbitration all actions, suits, claims, demands and proceedings regarding the TRUST fund.
- k) To appoint constituted attorney or agents and to delegate to such attorneys/agents ~~all or any of the powers~~ vested on them under these presents and from time to time remove such attorneys/agents and to appoint other(s) in his/her/their place(s).
- l) To appoint or make provisions for the appointment of any person(s) (including all or any of the TRUSTEES or Adminisrator or Managing Trustee or otherwise)for the purpose of the administration of the TRUST in such manner and subject to such rules and regulations as the TRUSTEES may prescribe.

- m) To make ,alter or modify schemes ,rules and regulations for carrying out the objects of the TRUST and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the TRUST and otherwise for giving effect to the objects of the TRUST.

9. **Power & functions of the trustee :**

A trustee may be required to shoulder certain responsibilities, concerning particular job(s) in the management and administration of the trust properties and activities as well be assigned to him/her by trust board from time to time. In such case the concerned trustee is expected to work in all diligence for carrying out his/her duties and performance to full satisfaction and to best interest of the trust.

10. **Funds Management :-**

The Board of trustees may from time to time open and maintain in the name of the trust any banking accounts with such schedule bank/s and in central/provisional co-operative banks or other approved banks as may from time to time determined by the trust board and shall forth with pay or cause to the paid ,the rents incomes, profits, dividends and all other moneys forming part of the trust funds to the credit of any such account or accounts such, such accounts shall be operated by the trustees signed handed for an on behalf of the trust which will have to be ratified in the subsequent board's meeting .Similarly all other receipts like grant conation certificate etc. received by the trust towards trust fund or towards any specific purpose/projects/activity shall also deposited in bank/s as above in the name of the trust in one or more accounts. All such accounts are also to be operated by the trustee/s for and on behalf of trust and shall have to be ratified as described above.

11. **Accounts & Audit :-**

The board shall maintain regular accounts of the trust fund and systematic programmers and projects, assistance and shall get the same duly audited by a firm of chartered accountants. The accounts and audit reports shall be published annually along with annual report of the trust.

12. **Financial year :-**

The accounts of the trust shall be closed on the 31<sup>st</sup> march every year with annual stock taking the accounts prepared.as such the financial year of the trust shall count from the 1<sup>st</sup> April to 31<sup>st</sup> March.

13. **Seal :-**

There shall be a common seal of the trust which shall be used as per direction of the trust board or by the direction of the settler-cum-Managing Trustee. The composition of said seal may be altered from time to time upon the resolution of the trust board.

14. **Amendments :-**

The trust board may unanimously make any amendments add to the rules may consider necessary for the better management of the administration of the trust properties and activities. But in no case the trust board can make amendment to the main feature fundamental

15. Nature of the Trust :-

The Trust shall function on a non-political, recreational, secular and non-profitable public trust.
